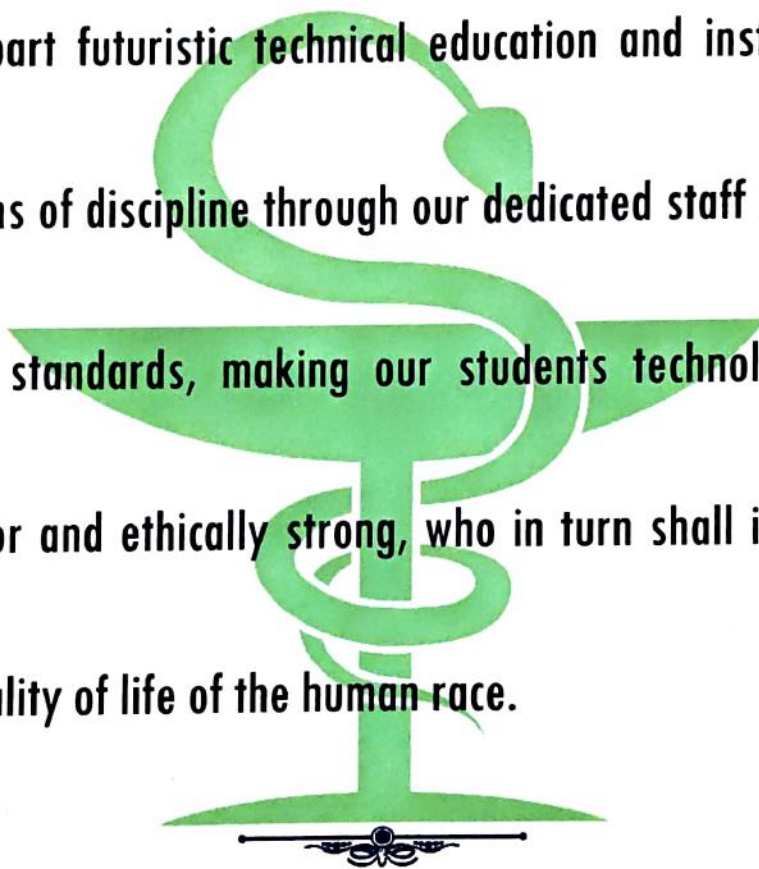

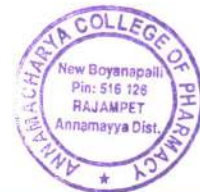

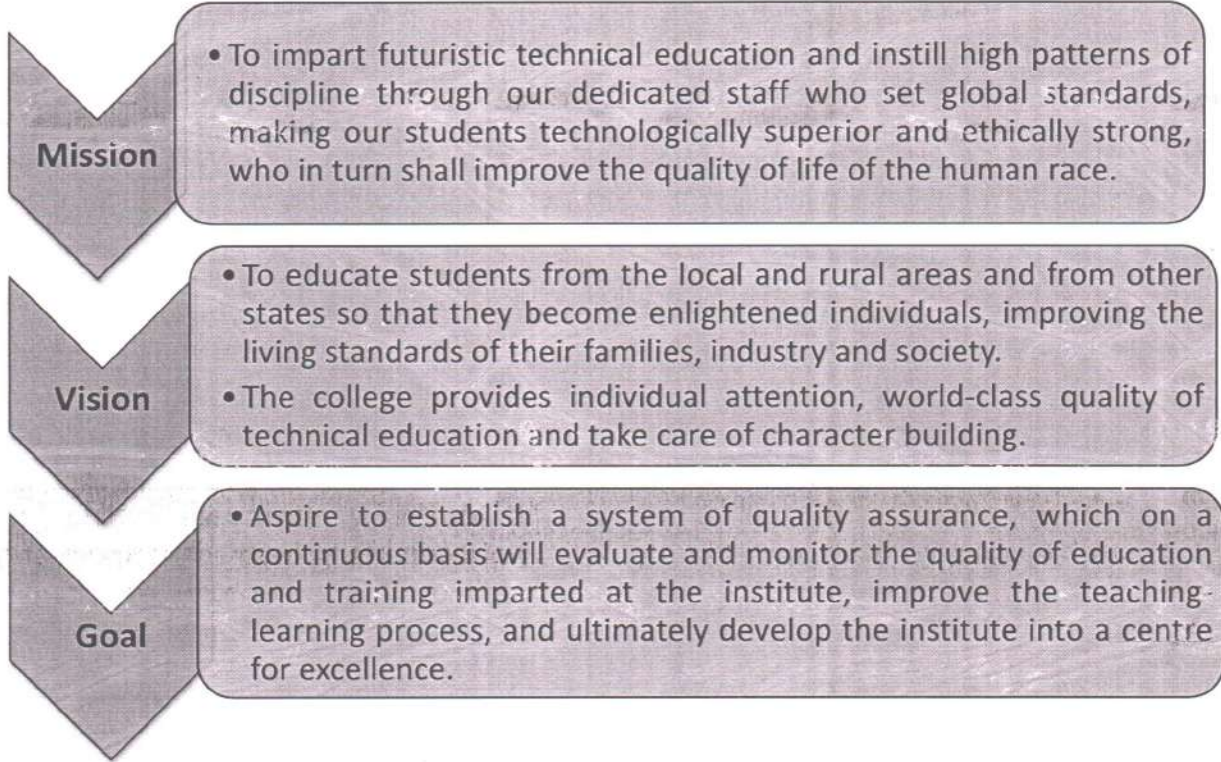

The Annamacharya Educational Trust was established in the year 1997.

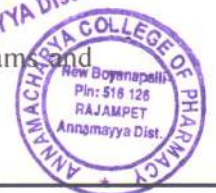
The Trust came into existence to promote quality education. Their objective is to start various courses, to impart futuristic technical education, and install high patterns of discipline in this academic curriculum.

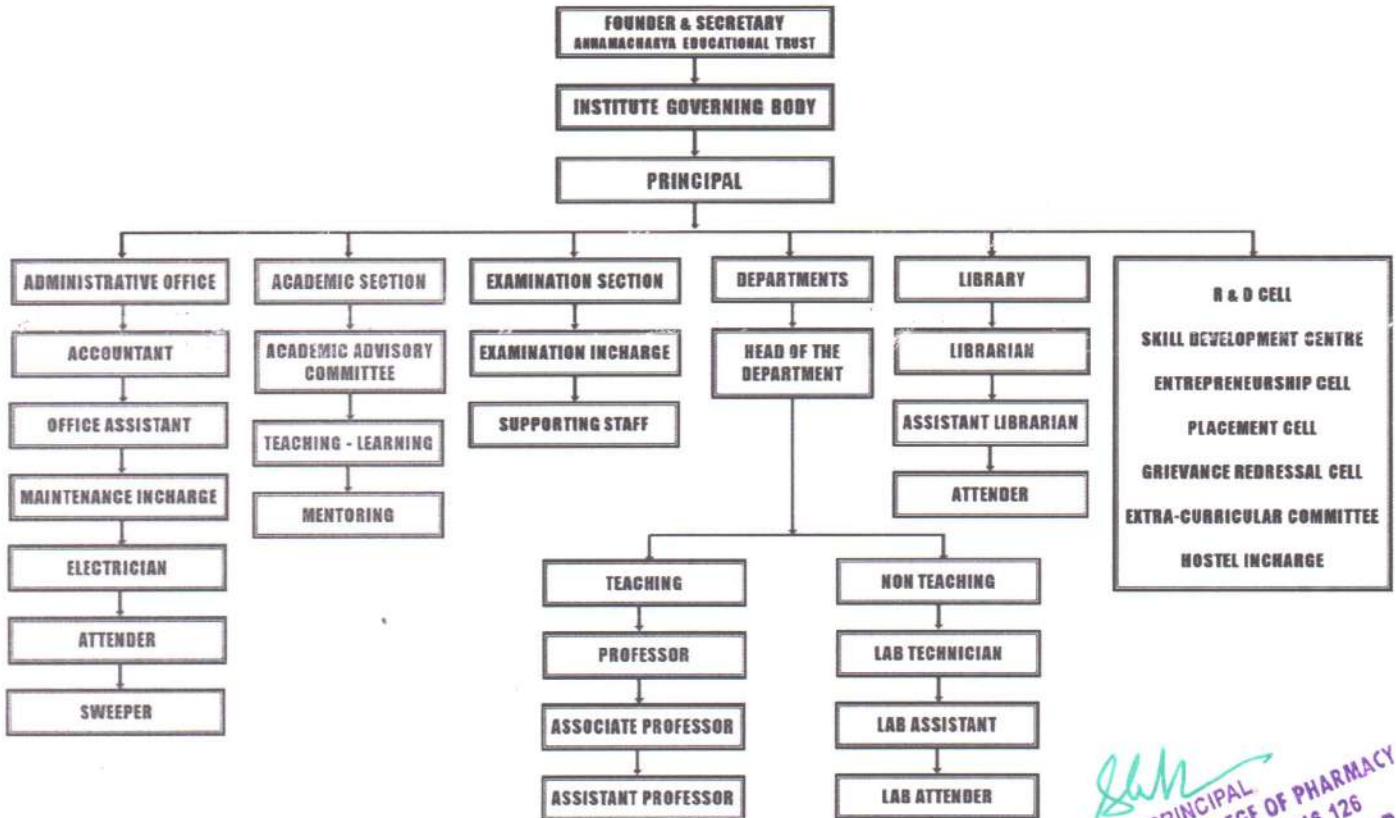
