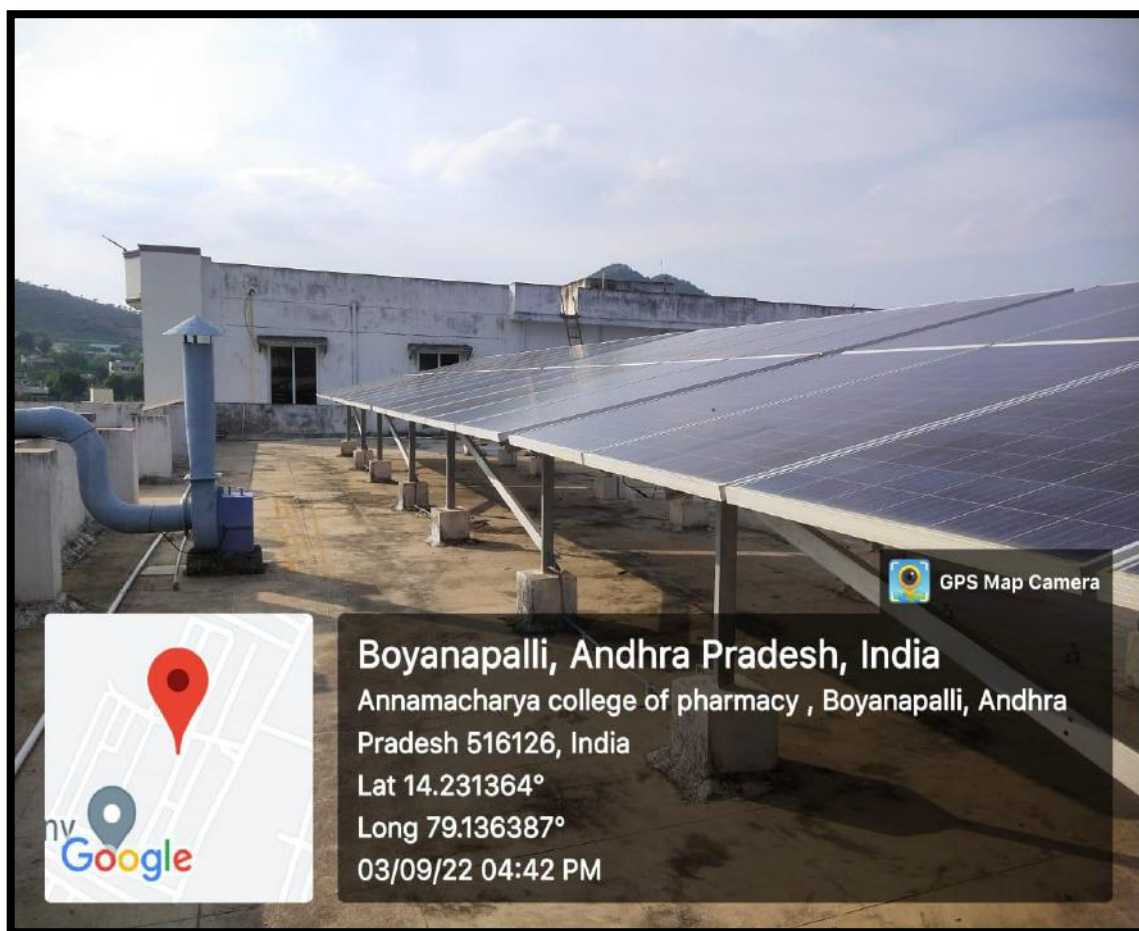

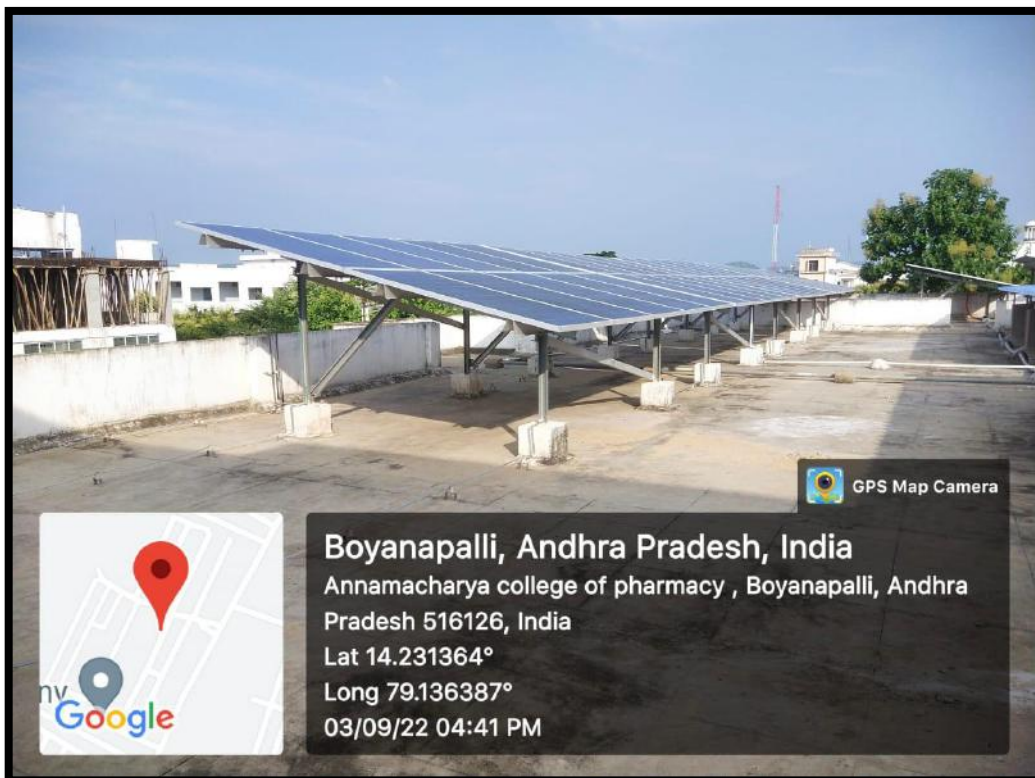

Waste management:

Solid waste management

- Separate bins are maintained in campus to collect bio degradable and non-bio-degradable waste.
- Fertilizers are not used to maintain the medicinal garden, instead of compost of bio degradable plant waste is used as manure.
- Non degradable waste is discarded separately.

Liquid waste management

- Institution has well established sinks in laboratories and drainage system through which liquid waste get discharged into the ground pits.

3. Water Conservation:

As the college is located in a hot climatic zone, our institute knows the importance of conservation and the best utilization of water resources. The college maintains and generates water resources. Our maintenance Staff regularly inspects tap leakages and attends to repair needs immediately to avoid loss of potable water.

RO Plant: Our institution utilizes water discharge from RO plant for gardening.

Rain water harvesting: Rain water is collected through a well-connected pipe work delivery system. This arrangement is helpful in collecting water, which is then collected into pits, specially constructed for this purpose. The rain water stored in the pits is used for the maintenance of garden in the campus.

Bore well: Our campus is having bore well, which gets recharged with rain water pits surrounded by the bore well and increases ground water levels.

Construction of Tanks and bunds: Institution is having tank which is useful for water storage and institution needs are fulfilled by the help of water storage tank.

Maintenance of water bodies and distribution system in the campus:

There are multiples pits surrounded by the campus maintains water bodies and also distribution.

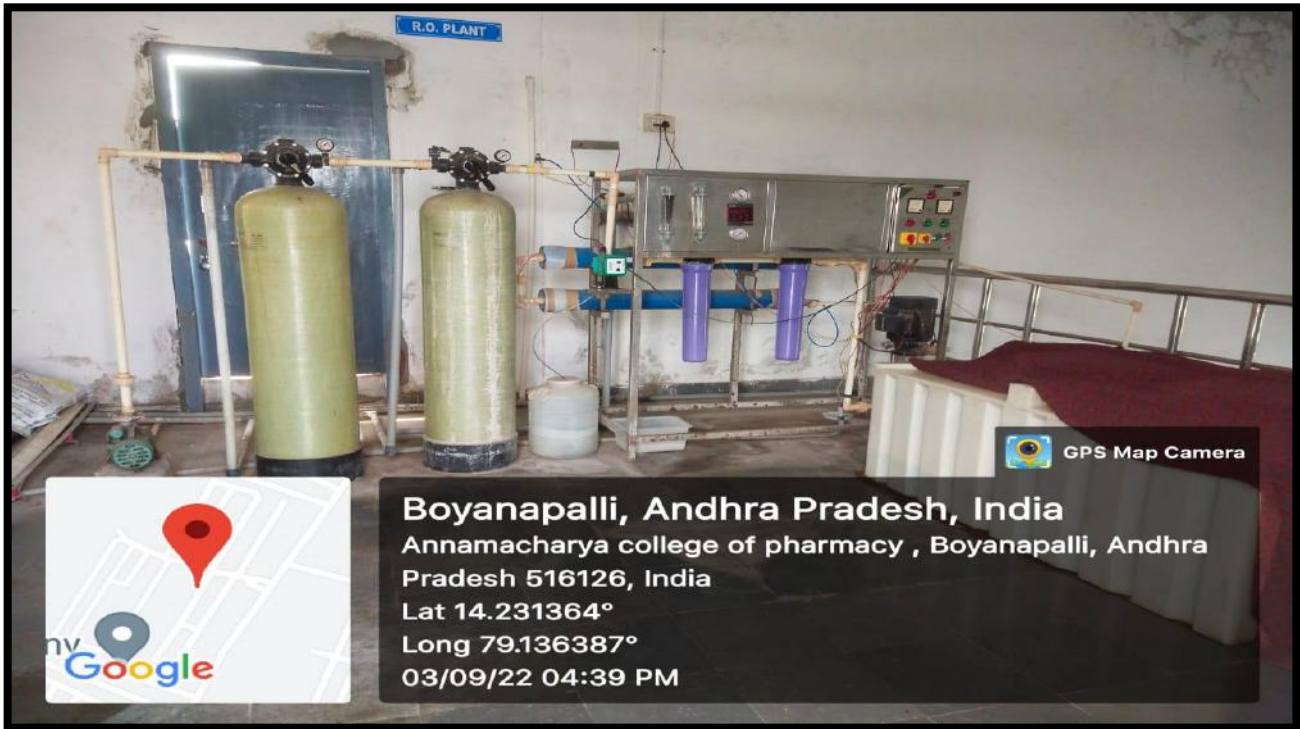

4. Green campus initiatives

Restricted Entry of Automobiles:

- Vehicles are not allowed into the campus, making the campus pollution free.
- All vehicles are parked outside the gate of the campus. Students nearby are encouraged to come by bicycles to college.

Battery-Powered Vehicles:

- Staff and students are encouraged to use electronic vehicles.

Pedestrian-friendly Pathways:

- The pathways inside the campus are well maintained and pedestrians can walk safely through the campus having two-way pedestrian.
- Pedestrian friendly pathways are properly marked with suitable sign boards. Many of the non-teaching staff and students in and around the location daily walk down to college.
