(57) Abstract :

The present invention discloses a novel ultra-performance liquid chromatography (UPLC) method for the accurate and efficient estimation of Sitagliptin and Simvastatin in a pharmaceutical composition. The method utilizes a specific mobile phase and column and employs a photodiode array detector for detection. The developed method is validated according to international guidelines and demonstrates excellent linearity, precision, accuracy, specificity, and robustness. The method provides a reliable and time-saving solution for the routine analysis of Sitagliptin and Simvastatin in bulk and tablet dosage forms.
